HNUG TXOG
ENROLLMENT FREQUENTLY ASKED QUESTIONS**



Tsev Neeg thiab tus Saibxyuas tej lus Hnug:

1. *Kuv yuav ua cas sau npe yog kuv tsis muaj ib qhov chaw nyob ruaj tiag?*

Koj qhov chaw nyob yuav yog qhov chaw uas koj nyob hmo ua ntej koj tuaj sau npe tab txawm tias nyob hauv tshab, so ib qho twg, li tej no. Qhov chaw nyob no yuav siv los xyuas rau hais tias yog lub tsev kawm ntawv rau koj qhov chaw nyob. Koj yuav tau ua kom tiav daim ntawv [Voluntary Information Sheet](#) thaum tuaj sau npe. Hauv Tsev Ntawv, *District*, muaj khookas *McKinney-Vento program* cov lis dej num yuav pab tau koj txog qhov sau npe nrog rau li thauj mus los yog xav tau kev pab. Hu tau lawv rau ntawm (920) 448-7326.

2. *Kuv tus tub xeeb ntxwv/ntxhais xeeb ntxwv nrog kuv nyob thiab kuv pub rau nws noj nws haus thiab pab nyiaj txiag rau nws. Nws Niamtxiv/Saibxyuas nyob sab nraud dhau ciam teb ntawm Green Bay Area Public School District. Kuv yuav ua li cas sau nws npe kawm ntawv?*

Yog tus Menyuam yeej nrog koj nyob uas tsis yog ua kom tau kawm nyob rau hauv *Green Bay Area Public School District* xwb, Niamtxiv/Saibxyuas yuav tau ua kom tiav daim ntawv [Request for Residency and Educational Guardianship Form](#). Koj yuav tau ua kom tiav daim ntawv [Educational Guardianship - Acceptance of Responsibility](#) thiab Tsab Ntawv Sau Npe, nrog rau Pov Thawj ntawm Chaw Nyob thiab Hnub Yoog.

3. *Kuv tus ntxhais xeeb ntxwv tamsim no nrog kuv nyob raws li kev pom zoo ntawm kuv tus kheej thiab tus xeeb ntxwv Niamtxiv/Saibxyuas. Kuv thiab kuv tus xeeb ntxwv Niamtxiv/Saibxyuas nyob hauv Tsev Ntawv, District, tej ciam teb. Kuv yuav ua cas sau nws npe kawm ntawv?*

Tus Menyuam Niambtxiv/Saibxyuas yuav tau ua kom tiav daim ntawv sau npe. Tus Menyuam thaj chaw nyob lub tsev kawm ntawv ces yuav yog los ntawm Niamtxiv/tus Saibxyuas qhov chaw nyob. Niamtxiv/Saibxyuas yuav tsum ua kom tiav daim ntawv [Rights to Records and/or Educational Decisions](#) form (Niamtxiv/Saibxyuas yuav tau kos qhov xaiv ob yam nyob hauv daim ntawv).

4. *Kuv yog nrog lwm tus nyob thiab muab tsis tau pov thawj txog chaw nyob.*

Cov yim neeg uas yeej qhia tau tseeb tias nyob rau ib lub tsev twg nrog rau lwm tus laus uas nyob hauv Tsev Kawm Ntawv muaj peev xwm sau tau daim ntawv qhia txog chaw nyob [Co-Residency Verification](#) form. Ob leeg ntawm Niamtxiv/Saibxyuas thiab tus Los-Nyob, *the Co-Resident*, yuav tau ua daim ntawv kom tiav thiab xee npe rau tsab ntawv no. Tus Los-Nyob, *the Co-Resident*, yog tus Laus Pab - Chaw Nyob uas Niamtxiv/Saib Xyuas thiab tus/cov Menyuam los nrog nyob thiab tus laus yuav tau qhia ua pov thawj txog ntawm qhov nrog tsev neeg no nyob.
